Declaration (including compulsory Food Chain Information)

- All prime lambs consigned to McIntosh Donald are under 12 months of age, (i.e. No incisor teeth have erupted through the gum). Any lambs which are slaughtered and are classified as over 12 months will be paid at realisation..
- Only animals born, reared and finished in Scotland and have continuous Farm Assurance status from birth will be eligible for the 'Scotch Lamb' label. Non Scotch lamb will have resided on farm assured holdings for no less than the last 60 days.
- All lambs supplied must be identified by tagging and comply with current legislation and be fully identifiable throughout the animals' movement history.
- These animals have been on the final producers holding for at least 20 days and will have been resident on no more than 3 farms
- No illegal substances or feed containing ingredients of animal origin have been used in the rearing or finishing of these animals. No digestive enhancers/hormones have been administered to these animals.
- Withdrawal periods have been observed for all veterinary medicines and other treatments (e.g. dipping) administered to the animals while in my ownership and previous ownership(s).
- To the best of my knowledge the animals are not suffering from any disease or condition that might affect the safety of meat derived from them.
- All hauliers must be members of the Farm Assured Haulier Scheme.
- These animals meet Vion Group / MHS cleanliness grade 1 & 2. Should any be above this grade I understand they will be clipped at my expense.
- Sheep and goats on the holding are not under movement restrictions for animal disease or public health reasons (excluding a 6-day standstill
- No analysis of samples taken from the animals on the holding or other samples on the holding has shown that the animals in this consignment may have been exposed to any disease or condition that may affect the safety of meat, or to substances likely to result in residues in meat
